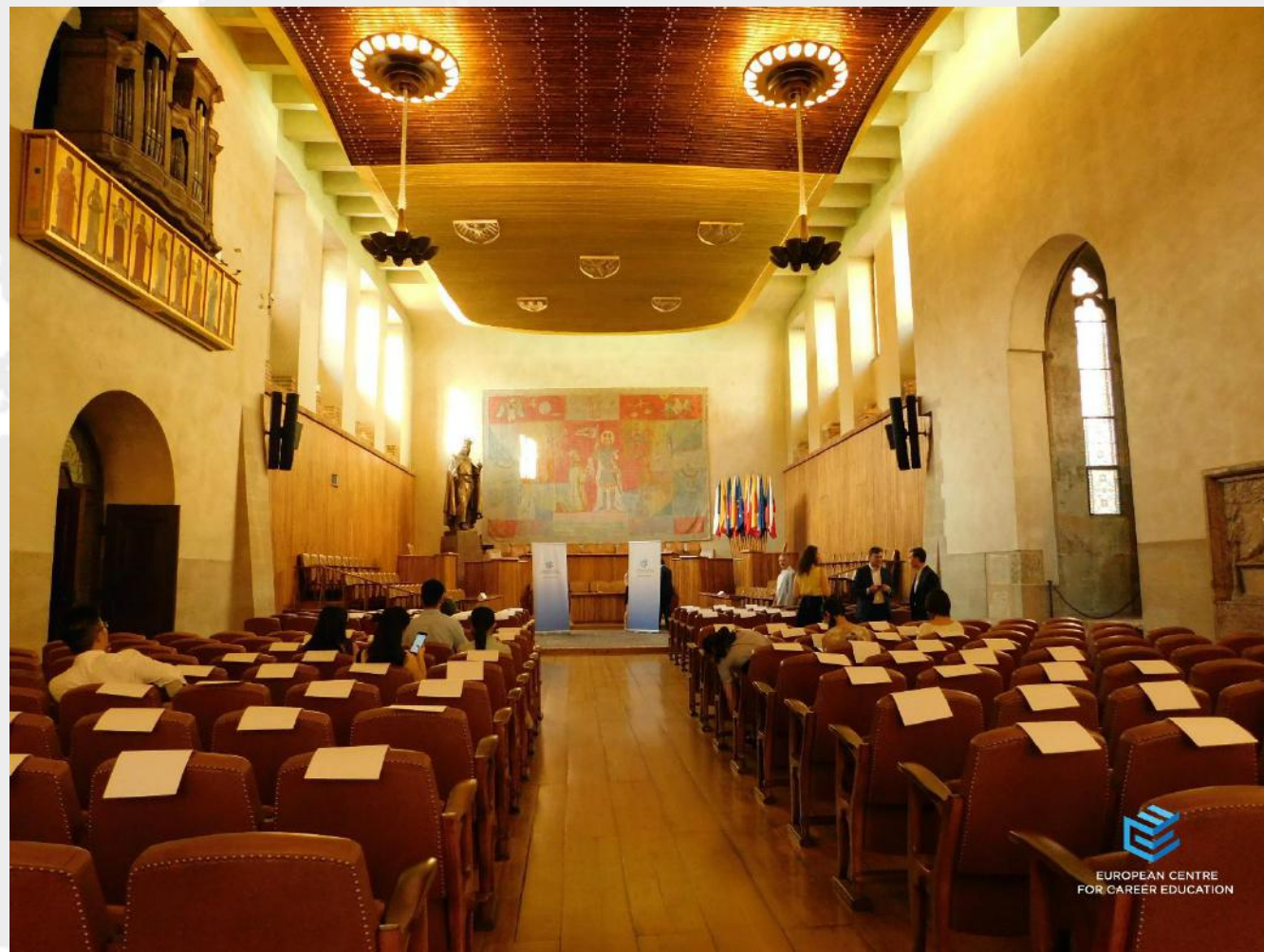



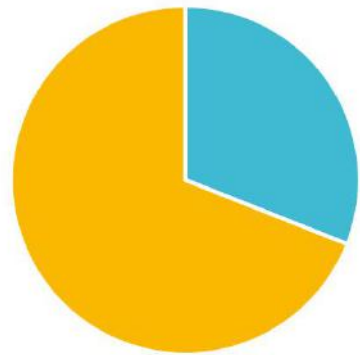

性别比例



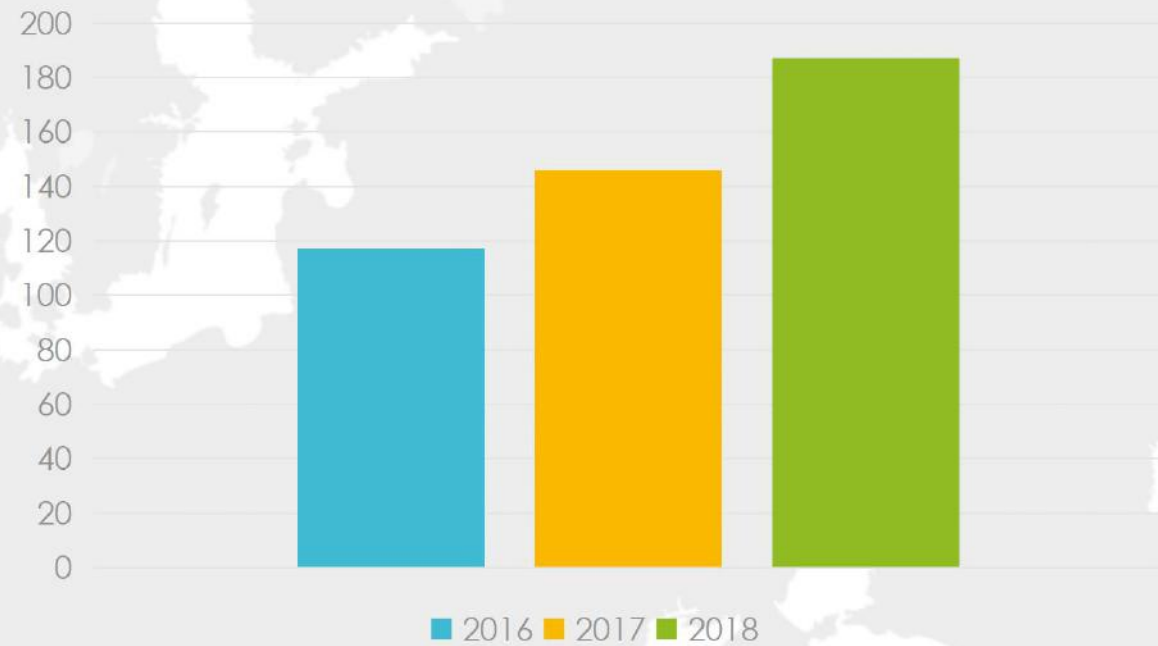

项目背景
